La Universidad Vizcaya de las Américas y la Universidad de Woosong (como se referirá de ahora en adelante a nuestras dos universidades) reconocen el promover intercambios académicos y de cooperación dentro del siguiente acuerdo.

En un espíritu de amistad y entendimiento mutuo nuestras dos instituciones acuerdan enriquecer el intercambio académico y la colaboración a través de lo siguiente:

1. Ambas universidades convienen en intercambiar materiales académicos escritos y publicados, información de tipo educativo e invitarse mutuamente a participar en reuniones académicas organizadas en cada institución.
2. Ambas universidades convienen en intercambiar profesorado, estudiantes e investigadores con el propósito de enseñanza, estudio e investigación académica. También convienen en cooperar en la organización de conferencias académicas y en otros asuntos de interés mutuo.
3. Las actividades que serán iniciadas para la realización de estos objetivos serán determinadas en cada caso mediante convenios particulares en concordancia con las normas y regulaciones de cada institución y estarán sujetas a los fondos disponibles por cada una de las universidades.
4. Los representantes de cada universidad se consultarán mutuamente en intervalos regulares para considerar el progreso de los programas mutuos y evaluar proyectos futuros.
5. Este convenio será válido por cinco años a partir de la fecha de la firma y podrá renovarse automáticamente por períodos sucesivos de cinco años. En caso de que alguna de las partes desee

**Memorandum of Understanding**

Universidad Vizcaya de las Américas and Woosong University (henceforth referred to as our two universities) both acknowledge to promote academic exchanges and cooperation within the following agreement.

In a spirit of friendship and mutual understanding, our two institutions both agree to enhance the level of academic exchange and collaboration through the following:

1. We agree to exchange written and published academic materials, educational information, and invite each other to take part in academic meetings organized by our two universities.
2. We agree to exchange faculty, students and researchers for the purpose of teaching, study and academic research. We also agree to cooperate in organizing academic conferences on issues of mutual concern.
3. The activities to be initiated in order to realize these objectives shall be determined in each case through particular agreements, in accordance with the rules and regulations of each institution, and subject to available funding by each party.
4. Representatives of the parties to the agreement shall consult, at regular intervals, to consider the progress of mutual programs and to evaluate future projects.
5. This agreement shall be valid for five years from the date of signing and may be automatically renewed for successive five-year periods. Should one of the parties wish to terminate the agreement, such notice should be given in writing at least six months prior to the termination period.





## Admission Process – Exchange Students

1. **Submission of online application** via the admission link (<https://wsu.embark.com/auth/register>), with all supporting documents, by **Monday 5 January 2020.**
  - SIS online admissions application form to be filled out
  - Proof of English proficiency (IELTS, TOEFL) - desirable
    - BBA language requirements: minimum IELTS 5.5, TOEFL IBT 61
    - MS in Culinary Arts and MSc International Hospitality Management language requirements: IELTS 6.0 or TOEFL IBT 79.
    - Ph. D. Hospitality & Tourism Management language requirements: minimum IELTS 6.0 or TOEFL IBT 79.
  - Passport copy
  - Grade transcripts: scanned with mandatory English translation are acceptable.
  - Recommendation letter
  - Nomination letter (issued by the home university)
  - Resume / CV: for graduate applicants only
2. **Verification of documents** by our Admissions Department
3. **Issuance of an acceptance letter and payment invoice** with a deadline upon admission
4. **Sending of invitation and guarantee letters** for the visa application after fee payment is made through wire transfer. **The D2 visa is the only eligible visa for international students in Korea.**
5. A mandatory insurance policy will go in effect from July 16, 2019 in Korea and will be payable directly to the government. The fee is ₩56,000 (USD 47) per month.
